



What is an implementing act?





Implement or supplement/amend?

- What?
 - A delegated act tells what the MS must do
- How?
 - An implementing act tells <u>how</u> MS should act to carry out the obligations in the basic act
 - An implementing act cannot add anything to the basic act. It can only give effect to the existing rules



Control of implementing acts

- Comitology procedure
 - Advisory procedure
 - Examination procedure
- EP and Council
 - Right of information Comitology register
 - Right of scrutiny if an act is considered exceeding
 - the implementing powers

- Public consultation
 - Feedback from citizens and stakeholders on the Better Regulation Portal (4 weeks)


Advisory procedure

 If vote in the Committee > simple majority of component members

 Commission decides taking the utmost account of the discussions and opinion delivered








Structure of a Commission Decision

- Title
- Preamble
 - Citations, references
 - Recitals, statements of reason
- Enacting terms
 - Subject matter and scope
 - Definitions
 - Provisions of the act
 - Transitional and final provisions



Implementing Decision Article 19 (2)

- Adopting the list of skills, competencies and occupations of the "European classification"
- For the purpose of automated matching through the EURES common IT platform
- "European classification" is the occupations, skills and competences of ESCO as published on 28 July 2018
- Consultations before any future updating, which will require an amendment of the Decision
- Publication of the list
- Entry into force 20 days after its publication in the OJ (August 2018)
- *MS to establish mapping tables without undue delay and no later than in three years* (EURES Regulation Art 19 (3))



Implementing Decision Article 19 (6)

- Adopting of technical standards and formats necessary for
 - the automated matching on the EURES IT platform using the "European classification" and
 - the interoperability between national systems and the "European classification"



Main elements - 19 (6)

- MS that use national, regional or and sectoral classifications for job vacancies or job applications shall, when making them available to the EURES portal create and use machine readable mapping tables between these classifications and the "European classification"
- The standards and formats are:
 - The set of information included in the mapping tables as specified in Annex.
 - A syntax to express this set of information
- MS shall ensure that national codes in JVs and CVs are replaced or complemented by "European classification" codes using the mapping tables
- Publication of mapping tables as LOD
- MS/NCO to appoint Single points of contact
- Consultations before any future updating of standards and formats
